1. Product Scope & Preface

This document provides license information for the congatec BIOS versions B7E3R016 used with congatec boards conga-B7E3. The BIOSes are typically delivered in binary form, embedded into the SPI flash of the mentioned congatec CPU boards, or as binary file directly to the end customer.

The above mentioned congatec software may contain Open Source Software (OSS) components, licensed under an OSS license and/or other third party software components.

The OSS licenses may require congatec to provide a list of the included OSS components together with their licenses to our customers and/or to distribute the list of OSS components together with their licenses as part of the respective congatec software delivery or the delivery of the hardware products that include this congatec software.

Certain OSS licenses entitle the customer to request the sources of the respective OSS components from congatec. The affected OSS code can be obtained from congatec by sending a specific request within three years after the delivery of the congatec software or hardware.
