## 1. Product Scope & Preface

This document provides license information for the congatec BIOS versions B7E3R018 used with congatec boards conga-B7E3. The BIOSes are typically delivered in binary form, embedded into the SPI flash of the mentioned congatec CPU boards, or as binary file directly to the end customer.

The above mentioned congatec software may contain Open Source Software (OSS) components, licensed under an OSS license and/or other third party software components.

The OSS licenses may require congated to provide a list of the included OSS components together with their licenses to our customers and/or to distribute the list of OSS components together with their licenses as part of the respective congated software delivery or the delivery of the hardware products that include this congated software.

- d) Each Contributor represents that to its knowledge it has sufficient copyright rights in its Contribution, if any, to grant the copyright license set forth in this Agreement.

#### 3. REQUIREMENTS

A Contributor may choose to distribute the Program in object code form under its own license agreement, provided that:

- b) its license agreement:
- i) effectively disclaims on behalf of all Contributors all warranties and conditions, express and implied, including warranties or conditions of title and non-infringement, and implied warranties or conditions of merchantability and fitness for a particular purpose;
- ii) effectively excludes on behalf of all Contributors all liability for damages, including direct, indirect, special, incidental and consequential damages, such as lost profits;
- iii) states that any provisions which differ from this Agreement are offered by that Contributor alone and not by any other party; and
- iv) states that source code for the Program is available from such Contributor, and informs licensees how to obtain it in a reasonable manner on or through a medium customarily used for software exchange.



When the Program is made available in source code form:

- a) it must be made available under this Agreement; and
- b) a copy of this Agreement must be included with each copy of the Program.

Contributors may not remove or alter any copyright notices contained within the Program.

Each Contributor must identify itself as the originator of its Contribution, if any, in a manner that reasonably allows subsequent Recipients to identify the originator of the Contribution.

#### 4. COMMERCIAL DISTRIBUTION
